

Senza lokhu ngamalungiselelo ezinkontileka nalezi zinkampane zangaphandle. Sithatha nezinyathelo zangaphakathi ukuze siqinisekise ukuthi izinkampane zangaphandle esizimisayo zineziyathelo ezifanele zokuvikela imininingwane esizinikeza yona.
- 15.8. I-FSCA isebeenzisa izilawuli zokuvikeleka, eziyi-elektronikhni nezingokoqobo eziklayelwe ukulondoloza ubumfihlo, ukuvimbela ukulahleka, imvume engagunyaziwe nokoniwa kwemininingwane abantu abangagunyaziwe. Ukuvikeleka kwamakhompyutha kwe-FSCA kuhambisana namafremuwekhi omthetho wemboni ukuze kuqinisekiswe ukulawulwa kobungozi bokuvikeleka kwamakhompyutha okusebenzayo kwenhlangano.
