**SETTLEMENT AGREEMENT IN TERMS OF SECTION 6B(7)(a) OF THE
FINANCIAL INSTITUTIONS (PROTECTION OF FUNDS) ACT, 28 OF 2001**

PARTIES TO THE AGREEMENT

1. The parties to this agreement are the Registrar of Pension Funds ("the Registrar") herein represented by Jurgen Arnold Boyd in his capacity as the Deputy Registrar of Pension Funds;

and

Qmulate (Pty) Ltd trading as Mianzo Asset Management ("Respondent), a company duly incorporated and registered in accordance with the laws of the

Republic of South Africa, bearing registration number 2006/018192/07. The Respondent is represented by Luvo Tyandela in his capacity as the managing director of the Respondent, and who warrants that he is authorized by the Respondent to conclude this agreement.

WHEREAS

2. The Registrar is of the opinion that the Respondent contravened section 13B(1) of the Pension Funds Act, No.24 of 1956 (Act).
3. The Respondent wishes to enter into a settlement agreement with the Registrar as contemplated in section 6B(7)(a) of the Financial Institutions (Protection of Funds) Act, No 28 of 2001 ("the FI Act").

NOW THEREFORE IT IS AGREED AS FOLLOWS

4. It is agreed between the parties that the Respondent contravened section 13B(1) of the Act in that during the period 01 December 2010 to 05 April 2011 it administered investments on behalf of a pension fund without the approval of the Registrar.
5. The Registrar took into account the following mitigating factors:
 - 5.1. The Respondent accepted responsibility for the contravention;



5.2. The Respondent co-operated with the Registrar's investigation and enforcement action;

6. In light of the above, the parties have agreed that the Respondent will pay a penalty of R10 350 on or before 30 November 2011, in settlement of the matter.
7. This agreement is subject to the approval of the Enforcement Committee and the parties specifically record that they are aware of the possibility that the Enforcement Committee may not accept the terms of this agreement. If the Enforcement Committee declines to make this agreement an order, then in such event this agreement will be null and void.
8. If the Respondent does not comply with the terms of this agreement and the Registrar and/or the Financial Services Board (FSB) institutes legal proceedings to enforce the agreement, the Respondent consents to pay all legal costs to the Registrar and/or the FSB on the Attorney and Client scale.
9. No leniency or postponement given by the Registrar to the Respondent or any amendment to the terms and conditions of this agreement will be binding unless such postponement, leniency or amendment is reduced to writing and signed by the parties. Any leniency, postponement granted by the Registrar or any amendment to this Agreement shall not be a novation of the cause of action in terms whereof the Respondent was found to have contravened the Act.

10. Any receipt of a payment by the Registrar and/or the FSB after the due date shall be without prejudice to any of the rights of the Registrar and/or the FSB.

11. The parties choose as their domicilium citandi et executandi their respective addresses set out below for all purposes arising out of or in connection with this agreement at which addresses all the processes and notices arising out of or in connection with this agreement, its breach or termination may validly be served upon or delivered to the parties. However the notice contemplated in terms of section 6E of the FI Act may be delivered by electronic email. For the purpose of this agreement the parties' respective addresses shall be:
