- Section 26B(9) of the Financial Services Board Act No. 97 of 1990 states the following:  
*"The appeal board must conduct its hearings in public, unless the chairperson of the panel which conducts the hearing rules that specific persons or groups of persons be excluded from the hearing for a reason that would be justifiable in civil proceedings before a High Court."*
- Section 232(3) of the Financial Sector Regulation Act 9 of 2017 states the following:  
*"A panel must conduct any hearing it holds in public, but the person presiding over the panel may direct that a person be excluded from the hearing on any ground on which it would be proper to exclude a person from civil proceedings before the High Court."*
