FSCA warns the public against Classic Financial Services One (Pty) Ltd (Classic) and its director, Mr Jacobus Stephanus Geldenhuis

The Financial Sector Conduct Authority (FSCA) warns the public to act with caution when conducting any financial services related business with Classic Financial Services One (Pty) Ltd (Classic) and its director, Jacobus Stephanus Geldenhuis (Mr. Geldenhuis).

The FSCA wishes to inform the public that neither Classic nor Mr. Geldenhuis are authorized to give any financial advice or render any intermediary services in terms of section 8 of the Financial Advisory and Intermediary Services Act, 2002.

The FSCA has successfully conducted a search and seizure operation at the premises of Classic on 12 October 2022, in terms of the Financial Sector Regulation Act of 2017 (FSR Act). The search and seizure operation was part of an ongoing investigation by the FSCA into the business activities of Classic and Mr. Geldenhuis. The investigation was initiated after the FSCA received complaints.

The FSCA also worked with the Financial Intelligence Centre (“the FIC”) who issued directives to two banks to freeze funds in the bank accounts of Classic. We took this step to protect possible funds of investors.

We also reported the matter to the Office of the National Director of Public Prosecutions, and more specifically its Asset Forfeiture Unit in Johannesburg (“AFU”) and who successfully applied for a preservation order of the funds in question. The collaboration between the FIC, AFU and the FSCA has led to the safeguarding of some of the clients’ funds. The FSCA extends its gratitude to the FIC and NPA (AFU) teams for their assistance and contributions.

The FSCA will now examine the evidence, interview the parties involved and complete the investigation. Clients of Classic are encouraged to contact the FSCAs Business Centre through the following link <https://www.fscA.co.za/Pages/Contact-Us.aspx> .

On conclusion of the investigation, the FSCA will take the appropriate regulatory action and will support the Prosecuting Authority in their responsibilities.
