FINANCIAL ADVISORY AND INTERMEDIARY SERVICES ACT, 2002

EXEMPTION OF PARTICULAR PERSONS FROM QUALIFICATION REQUIREMENTS, NO. 16 OF 2015

I, Caroline Dey da Silva, Deputy Registrar of Financial Services Providers, hereby exempt under section 44(4) of the Financial Advisory and Intermediary Services Act, 2002, particular persons from provisions of the Act and certain measures promulgated thereunder, to the extent set out in the Schedule.

SCHEDULE

EXEMPTION OF PARTICULAR PERSONS FROM QUALIFICATION REQUIREMENTS, NO. 16 OF 2015

Definitions

- In this Schedule, "the Act" means the Financial Advisory and Intermediary Services Act, 2002, any word or expression to which a meaning is assigned in the Act shall have that meaning, and unless the context otherwise indicates-
 - "Category I financial services" means the financial services contemplated in the definition of Category I as defined in section 1(1) of the Determination of Fit and Proper Requirements;
 - "Determination of Fit and Proper Requirements" means the Determination of Fit and Proper Requirements for Financial Services Providers, 2008:
 - "Qualification requirements" means the applicable-
 - (a) Qualification requirement referred to in Column Two of Table E of the Determination of Fit and Proper Requirements; or
 - (b) Requirement to have a recognised qualification that appears on the list of recognised qualifications.

Extent and duration and conditions of Exemption

- 2. (1) The applicants for exemption referred to in Table A hereunder are exempted from the Transitional Provisions in paragraph 10 of the Determination of Fit and Proper Requirements insofar it relates to the qualification requirements until 31 December 2016, subject to the conditions that they must:
 - (a) on or before **30 November 2015** furnish the Registrar with evidence that they have enrolled for a qualification;
 - (b) on or before 31 July 2016 furnish the Registrar with their statement of results;
 - (c) immediately inform the Registrar of any matter that may impact on their ability to comply with the qualification requirement on expiry of the Exemption;
 - (d) immediately advise the Registrar of any change to the particulars furnished in and relating to their application for exemption; and
 - (e) prior to rendering any financial service to a client, disclose prominently in writing that they have been exempted from the qualification requirement as prescribed under the Act.

- (2) The applicants for exemption referred to in Table B hereunder are exempted from the Transitional Provisions in paragraph 10 of the Determination of Fit and Proper Requirements insofar it relates to the qualification requirements until **31 December 2017**, subject to the conditions that they must:
 - (a) on or before 30 November 2015 furnish the Registrar with evidence that they have enrolled for a qualification;
 - (b) on or before **31 July 2016** and **31 January 2017** respectively furnish the Registrar with their statement of results;
 - (c) immediately inform the Registrar of any matter that may impact on their ability to comply with the qualification requirement on expiry of the Exemption;
 - (d) immediately advise the Registrar of any change to the particulars furnished in and relating to their application for exemption; and
 - (e) prior to rendering any financial service to a client, disclose prominently in writing that they have been exempted from the qualification requirement as prescribed under the Act.
