#### 1. Definitions

In this Schedule, unless the context otherwise indicates -

**"Authority"** means the Financial Sector Conduct Authority as defined in section 1(1) of the Financial Sector Regulation Act, 2017 (Act No. 9 of 2017);

"transitional period" means the period 30 September 2004 to 31 December 2009;

"**unit standard**" has the meaning assigned to it in section 1 of the National Standards Bodies Regulations, 1998, published in Government *Gazette* No 18787 of 28 March 1998 under section 14 of the South African Qualifications Authority Act, 1995 (Act No. 58 of 1995).
