


**FSCA RF NOTICE 23 OF 2024**  
**PENSION FUNDS ACT, 1956 (ACT NO. 24 OF 1956)**

**EXEMPTION OF CERTAIN FUNDS IN RELATION TO SPECIFIC PARTICIPATING EMPLOYERS  
FROM THE REQUIREMENTS OF SECTION 28 OF THE PENSION FUNDS ACT, 1956 (ACT NO. 24  
OF 1956)**

The Financial Sector Conduct Authority, under section 28(17) of the Pension Funds Act, 1956 (Act No. 24 of 1956) read with section 281(4) of the Financial Sector Regulation Act, 2017 (Act No. 9 of 2017) has exempted certain funds in relation to specific participating employers, as listed in Annexure A to this notice, from the provisions of section 28 of the Pension Funds Act, 1956 (Act No. 24 of 1956) to the extent set out in the Schedule.

**SCHEDULE**  
**EXEMPTION OF CERTAIN FUNDS IN RELATION TO SPECIFIC PARTICIPATING EMPLOYERS**  
**FROM THE REQUIREMENTS OF SECTION 28 OF THE PENSION FUNDS ACT, 1956**

**1. Definitions**

In this Schedule “**the PFA**” means the Pension Funds Act, 1956 (Act No. 24 of 1956) and “**the Act**” means the Financial Sector Regulation Act, 2017 (Act No. 9 of 2017), and any word or expression to which a meaning has been assigned in the Act or the PFA shall have the meaning so assigned to it unless a different meaning is assigned elsewhere in this Schedule, and—

“**applicant fund**” means a fund that applied for an exemption from paragraph 9.2(a) or paragraph 9.2(b) of the Board Notice, as prescribed in terms of section 28(17) of the PFA;

“**the Board Notice**” means Directive PF No. 4 published under section 28(17) of the PFA in Board Notice 75 of 2009, of Government Gazette 23238 of 8 June 2009;

“**FSCA RF Notice 5 of 2023**” means Exemption of funds from the conditions of Board Notice 75 of 2009, to qualify for an exemption from section 28 of the Pension Funds Act, 2023, published on 31 January 2023.

**2. Applicable legislation**

- (1) Section 28(2) of the PFA determines that, in the event of termination of a fund whether wholly or in part, a liquidator shall be appointed in the manner directed by the rules, or, if the rules do not contain directions as to such appointment, by the board, but such appointment shall be subject to the approval of the Authority and the period of liquidation shall be deemed to commence as from the date of such approval.
- (2) Section 28(17) of the PFA determines that the Authority may, under certain circumstances, grant an exemption from the provisions of section 28 and prescribe the requirements to be complied with for such exemption to be granted.
- (3) FSCA RF Notice 5 of 2023 exempts certain applicant funds from the circumstances under which an application for exemption from the provisions of section 28 of the PFA will be considered as set out in paragraph 9.2(a) and 9.2(b) of the Board Notice, subject to the conditions set out in FSCA RF Notice 5 of 2023.
- (4) Section 281(4) of the Act requires that where the Authority grants an exemption in terms of a financial sector law, the requirements of section 281(3) must be met, and such exemption must be published. The PFA is a financial sector law as defined in section 1(1) read with Schedule 1 of the Act.

**3. Exemption of specific entities by the Authority**

Pursuant to section 28(17) of the PFA, the Authority exempted certain funds in relation to specific participating employers under umbrella funds as listed in Annexure A from the requirements of section 28 of the PFA.

**4. Conditions of exemption**

The exemptions referred to in paragraph 3 were subject thereto that:

- (1) on the date that the fund takes a resolution to liquidate or partially liquidate the fund due to withdrawal of a participating employer, the fund or the relevant participating employer withdrawing did not have more than 100 members;
- (2) the fund or relevant participating employer has assets less than R50 million;
- (3) the surplus apportionment scheme or nil return has been approved or noted by the Authority; and
- (4) all the remaining requirements and conditions in the Board Notice, and specifically paragraphs 9.3, are complied with.

**5. Commencement of exemptions granted**

The relevant effective dates of the exemption are listed in Annexure A.

**6. Short title**

This exemption is called the Exemption of certain funds in relation to specific participating employers from the requirements of section 28 of the PFA, 2 of 2024.
