



**FSCA RF NOTICE 5 OF 2026**

**PENSION FUNDS ACT, 1956 (ACT NO. 24 OF 1956)**

**EXEMPTION OF CERTAIN FUNDS FROM THE REQUIREMENTS OF REGULATIONS 37, 38 AND 39 MADE IN TERMS OF SECTION 36 OF THE PENSION FUNDS ACT, 1956**

The Financial Sector Conduct Authority, under Regulations 37(3), 38(3) and 39(6) of the Pension Funds Act, 1956 (Act No. 24 of 1956) read with section 281(3)(b) of the Financial Sector Regulation Act, 2017 (Act No. 9 of 2017), exempted certain funds listed in Annexure A to this notice from the provisions of Regulations 37, 38 and 39 made in terms of section 36 of the Pension Funds Act, 1956, to the extent set out in the Schedule.

## SCHEDULE

### EXEMPTION OF CERTAIN FUNDS FROM THE REQUIREMENTS OF REGULATIONS 37, 38 AND 39 MADE IN TERMS OF SECTION 36 OF THE PENSION FUNDS ACT, 1956

#### 1. Definitions

In this schedule “**the Act**” means the Financial Sector Regulation Act, 2017 (Act No. 9 of 2017) and “**the PFA**” means the Pension Funds Act, 1956 (Act No. 25 of 1956) and any word or expression to which a meaning has been assigned in the Act or the PFA shall have the meaning so assigned to it unless a different meaning is assigned elsewhere in this Schedule.

“**Default Regulations**” means Regulation 37, 38, 39 and 40 made in terms of section 36 of the PFA.

#### 2. Applicable legislation

- (1) Section 36 of the PFA provides that the Minister may make regulations, not inconsistent with the provisions of the PFA.
- (2) Regulation 37 of the Default Regulations requires the board of a fund with a defined contribution category to include in its investment policy statement the provision of one or more default investment portfolios.
- (3) Regulation 38 of the Default Regulations requires the rules of the fund to provide for members who leave the service of a participating employer before retirement to become paid-up members.
- (4) Regulation 39 of the Default Regulations requires the board of the fund to establish an annuity strategy.
- (5) Regulation 40 of the Default Regulations provides that, other than where specifically indicated, Regulations 37 and 38 do not apply to retirement annuity and preservation funds.
- (6) Section 281(4) of the Act requires that where the Authority grants an exemption in terms of a financial sector law, the requirements of section 281(3) must be met, and such exemption must be published. The PFA is a financial sector law as defined in section 1(1) read with Schedule 1 of the Act.

#### 3. Exemption of specific entities by the Authority

Pursuant to Regulations 37(3), 38(3) and 39(6) of the Act, the Authority exempted the funds listed in Annexure A from the provisions of regulations 37, 38 and 39 made in terms of section 36 of the PFA. These exempted funds are in the process of transferring their assets to other funds, paying the remaining benefits to members, or cancelling their registration.

#### **4. Conditions of exemption**

The exemptions referred to in paragraph 3 are subject thereto that—

- (1) the exempted fund must submit a written status report to the Authority regarding the progress on the transfer of assets and liabilities and the payment of benefits within a year from the date of the exemption being granted, and annually thereafter until the fund is deregistered or cancelled in accordance with the PFA;
- (2) the board members of the fund must finalise the deregistration or cancellation of the fund within two years from the date of the exemption being granted; and
- (3) where deregistration or cancellation is not finalised within 2 years in accordance with subparagraph (2) provide the Authority with –
  - (i) written reasons for the delay in finalising the deregistration or cancellation of the fund; and
  - (ii) the planned date for finalising the deregistration or cancellation of the fund.

#### **2. Commencement of exemptions granted**

The relevant effective dates of the exemptions are listed in Annexure A.

#### **3. Short title**

This Notice is called the Exemption of Certain Funds from the Requirements of the Default Regulations, 1 of 2026.
