2. ISANDULELO

- 2.1 UmThethosisekelo weRiphabhliki yeSewula Afrika, 1996 ("umThethosisekelo"), wamukela amalimi ali-12 asemthethweni, okusiNgisi, isiBhuru, Tshivenda, Xitsonga, Sepedi, Setswana, isiSwati, Sesotho, isiZulu, isiXhosa, isiNdebele, Siswati kanye neLimi lamaTshwayo leSewula Afrika (*South African Sign Language (SASL)*); uyelela ukwehla kokusetjenziswa nobujamo bamalimi wendabuko begodu ufuna bona umbuso uthathe amagadango asebenzako wokuphakamisa ubujamo nokuthuthukisa ukusetjenziswa kwamalimi la. UmThethosisekelo godu ufuna bona woke amalimi asemthethweni athokozele ukuhlonitjiswa okulinganako begodu aphathwe ngokulinganako.
- 2.2 Ukwenza lokhu, umThetho wokuSetjenziswa kwamaLimi asemThethweni, 2012 (umThetho we-12 ka-2012) ("umThetho"), umenyazelwe bona ukhuthaze ukusetjenziswa kwamalimi asemthethweni ekukhulumisaneni namalunga womphakathi; ukunikela ngomthetholawulo nokutjheja ukusetjenziswa kwamalimi asemthethweni ngurhulumende wesitjhaba ngeminqopho kaRhulumende; ukufuna ukwamukelwa komgomo wamalimi minyango yesitjhaba, ziinhlangano zombuso zesitjhaba kanye namabhizinisi wombuso wesitjhaba; begodu ulungisela ukusungulwa kweyunidi/iphiko lamalimi minyango yesitjhaba, ziinhlangano zombuso zesitjhaba kanye namabhizinisi wombuso wesitjhaba.
- 2.3 UmThetho lo usebenza kizo zoke iinhlangano zombuso zesitjhaba. IsiPhathimandla esiLawula ukuziPhatha komKhakha wezeeMali (i-FSCA) yihlangano yombuso yesitjhaba erhenyiswe kuTjhejuli 3 yomThetho wokuPhathwa kweeMali zomBuso (*Public Finance Management Act*), 1999 (umThetho woku-1 ka-1999) ("i-PFMA"). Ngakho-ke, umGomo lo wenziwe yi-FSCA ngokuthobela iindinyana zomThetho.

3. UMNQOPHO

Umnqopho womGomo lo kuveza bona i-FSCA izowuthobela njani umThetho begodu isebenzise amalimi asemthethweni ukwenza ngcono ukusebenzela amalunga womphakathi eekhungweni ezikulu nezilawulwako nokwenza ngcono amazinga wokuthobela.

5. IRHERHO NOKUSETJENZISWA

UmGomo lo usebenza kibo boke abasebenzi be-FSCA, ukufaka hlangana abosokontra kanye nanyana ngubani owenzela i-FSCA umsebenzi.

6. UBUJAMO BOKULAWULA KOMGOMO LO

UmGomo lo uqintelwe sigaba 4 somThetho, ngendlela elandelako:

- 6.1 Isigaba 4(1) siveza bona omunye nomunye umnyango wesitjhaba, iihlangano zombuso zesitjhaba kanye namabhizinisi wombuso wesitjhaba kufanele amukele umgomo wamalimi ngokusebenzisa kwawo amalimi asemthethweni;
- 6.2 IsiGaba 4(2) siveza bona umgomo wamalimi owamukelwe ngokwesigatjana (1) kufanele—
 - 6.2.1 sikhombe okungenani amalimi amathathu asemthethweni iminyango yesitjhaba, iihlangano zombuso zesitjhaba namkha amabhizinisi wombuso wesitjhaba ezizakuwasebenzisela iminqopho karhulumende;
 - 6.2.2 siqintele bona amalimi asemthethweni azokusetjenziwa njani ekukhulumisaneni kuhle nomphakathi, izaziso ezisemthethweni, iincwadi zikaRhulumende kanye nokukhulumisana hlangana norhulumende;
 - 6.2.3 sihlathulule bona iminyango yesitjhaba, iihlangano zombuso zesitjhaba namkha amabhizinisi wombuso wesitjhaba zizokukhulumisana njani kuhle namalunga womphakathi ilimi lawo elikhethiweko elingasi ngelinye lamalimi asemthethweni akhethiweko;
 - 6.2.4 sihlathulule bona amalunga womphakathi angawufumana njani umgomo wamalimi lo;
 - 6.2.5 sinikele indlela yokufaka iinngenhoyilo ukwenzela bona amalunga womphakathi akghone ukufaka iinngenhoyilo malungana nokusetjenziwa kwamalimi asemthethweni minyango yesitjhaba, iihlangano zombuso zesitjhaba namkha amabhizinisi wombuso wesitjhaba; begodu

6.2.6 ugadangiswe msinyana kuGazede, kodwana kungakapheli amalanga ama-90 ngemva kokwamukelwa kwawo.

7. IMIGOMO

Imigomo esekela umGomo lo ngile elandelako:

- 7.1 Ukuzibophelela ekuthatheni amagadango wokuphakamisa ubujamo nokuthuthukisa ukusetjenziswa kwamalimi wendabuko.
- 7.2 Ukuzibophelela ekuthuthukisweni kwawo woke amalimi eRiphabhliki kobana kuqinisekiswa ukuhlonitjiswa okulinganako nokuphathwa ngokulinganako kwamalimi asemthethweni njengombana kufunwa mbuso wethu wentando yenengi.
- 7.3 Ukwamukelwa kokusetjenziswa kwamalimi amanengi njengesisetjenziswa sokukhulisa ukusebenzisana ekwakheni inarha, ukuthuthukisa umnotho nokubumbana komphakathi.
- 7.4 Ukukhuthazwa kokuphathwa kuhle kwamalimi yi-FSCA ukuqinisekisa ukulawulwa kuhle kwekoro yembusweni ehlangabeza iindingo zomphakathi neqinisekisa ukufumaneka ngokulinganako kwezenzelwa nelwazi le-FSCA.
- 7.5 Ukukhandelwa kokusetjenziswa kwananyana ngiliphi ilimi (amalimi) ngeminqopho yokucaphaza, ukulawula nokubandlulula ngaphakathi kwe-FSCA.
- 7.6 Ukuzibophelela ekuqinisekiseni bona iinkundla zedijithali ze-FSCA kanye nemigadangiso yethungelelwano iyafumaneka begodu isetjenziswa babantu abahlukene, ukufaka hlangana abantu abakhubazekileko, ngokukhambisana nemikghwa emihle etjhugulukako yokufumaneka kwedijithali.
- 7.7 Ukuzibophelela ekusebenziseni imigomo elula yelimi kizo zoke iinkulumiswano eziqalene nomphakathi, khulukhulu lezo ezinqotjhiswe kumakhastama wezeemali. Ilimi lobuthekhiniki namkha lezomthetho lizakubalekelwa lapho kukghoneka khona begodu lapho ekungakghonekiko, lizakukhambisana neenhlathululo ezicacileko namkha iinrhunyezo.

8. UBUNJALO BEBHIZINISI LE-FSCA

I-FSCA isikhungo esizijameleko esisungulelwe ukulawula nokutjheja ukuziphatha kwamaziko wezeemali eSewula Afrika. Njengombana kuqintelwe esigabeni 57 somThetho wokuLawula umKhakha wezeeMali, 2017, iminqopho ye-FSCA ku–

- 8.1 thuthukisa nokusekela ukusebenza kuhle nokuthembeka kweemakethe zezeemali; kanye

- 8.2 nokuvikela amakhastama wezeemali ngoku–
- 8.2.1 khuthaza ukuphathwa kuhle kwamakhastama wezeemali maziko wezeemali;
- 8.2.2 nikela amakhastama wezeemali nalabo abangaba makhastama wezeemali amahlelo wefundiso yezeemali begodu ngenye indlela kukhuthazwe ilwazi ngezeemali nekghono lamakhastama wezeemali nalabo abangaba makhastama wezeemali ukuthatha iinqunto ezizwakalako zezeemali; kanye
- 8.3 nokusiza ekugcineni ukunzinza kwezeemali.

9. AMALIMI ASEMTHETHWENI WE-FSCA

9.1 Ukwamukelwa kwamalimi asemthethweni yi-FSCA

- 9.1.1 UmThetho ufuna bona i-FSCA yamukele umgomo wamalimi okhomba okungenani amalimi amathathu asemthethweni ezowasebenzisela "iminqopho karhulumende". Lokhu kutjho amalimi azokusetjenziswa khulu lokha nakukhulunywa namalunga womphakathi.
- 9.1.2 Ekukhombeni amalimi asemthethweni, i-FSCA phakathi kokhunye iyalelwa bona itjheje ukuthuthukisa amalimi wendabuko ebegade agandelelwe esikhathini esidlulileko.
- 9.1.3 Ekuqunteni bona ngimaphi amalimi asemthethweni ekufanele asetjenziswe, i-FSCA izokuhlhlwa kiyo yoke into ngezinto ezilandelako:
- 9.1.3.1 Ukusebenza;
- 9.1.3.2 lindleko eziphatheleneko;
- 9.1.3.3 Indawo;
- 9.1.3.4 Ikareko lomphakathi kanye/namkha isiqhema esithileko esiqothelweko; kanye
- 9.1.3.5 Ikghono le-FSCA.
- 9.1.4 Nanyana i-FSCA yamukela woke amalimi asemthethweni weRiphabhliki, amalimi alandelako amukelwe:
- 9.1.4.1 **IsiNgisi** (indlela yokuthintana);
- 9.1.4.2 Esiqhemeni samalimi wesiNguni (isiZulu, isiNdebele, Siswati kanye nesiXhosa), kwamukelwe **isiZulu**;
- 9.1.4.3 Esiqhemeni samalimi weSesotho (Setswana, Sepedi kanye ne-Sesotho), kwamukelwe **i-Setswana**;
- 9.1.4.4 **I-Tshivenda**, elinye lamalimi agade angatjhejwa ngaphambilini esingasiso sesiqhema samalimi, samukelwe; kanye
- 9.1.4.5 **nesiBhuru**, ngesinye samalimi angekho esiqhemeni samalimi, naso samukelwe.

- 9.1.5 I-FSCA izakuqinisekisa bona isebenzisa amalimi atjengiswe emutjhwani 9.1.4 ngeminqopho karhulumente njengombana kuhlathululwe emutjhwani 9.2.4 ngenzasi.

9.2 Ukusetjenziswa kwamalimi asemthethweni yi-FSCA

- 9.2.1 Ihlathululo yokobana ngimaphi amalimi azokusetjenziselwa iminqopho yebhizinisi kanye nokukhulumisana namalunga womphakathi nendlela amalimi lawo azokusetjenziswa ngayo, ihlathululwe ngenzasi.

9.2.2 Iminqopho yebhizinisi

I-FSCA yamukela isiNgisi njengendlela eqakathekileko yokukhulumisana begodu nelimi lokurekhoda ngeminqopho yebhizinisi–

- 9.2.2.1 ukukhulumisana namatlayenti wayo ahlukahlukene (abathengi kanye neenhlango ezilawulwako) ngokukhambisana negunya layo;
 - 9.2.2.2 malungana nokukhulumisana kwangaphakathi kwe-FSCA; begodu
 - 9.2.2.3 malungana nokukhulumisana kwayo norhulumente kanye/namkha nePalamente ngoNgqongqotjhe onesibopho.
- 9.2.3. Ebujamweni lapho imitlolo ebekufanele yenziwe ngesiNgisi kwaphela ikhonjelwa ngananyana ngiliphi ilimi elisemthethweni kunangesiNgisi, i-FSCA izokwenza bona kube namatjhuguluko arhunyeyizweko, ngokukhambisana nomutjhwana 9.1.3 ongehla.

9.2.4 Iminqopho kaRhulumente

I-FSCA izakusebenzisa isiNgisi namalimi asemthethweni avezwe ku-9.1.4 ngokobujamo ngabunye malungana neminqopho elandelako:

- 9.2.4.1 Ukukhulumisana namalunga womphakathi, kokubili ngomlomo nangokutlola, ukufaka hlangana, izaziso zomphakathi neememezelo, amatshwayo welwazi lomphakathi, amatshwayo akhomba iinsetjenziswa nezenzelwa (amavetjheni arhunyeyizweko ebujameni bemitlolo ebuthekhiniki);
- 9.2.4.2 Ukukhulumisana neembikiindaba (isib. umgadangiso, umrhatjho, umabonwakude, i-podcast, iwebhusayidi) – ngokuya ngominqopho nekundla.
- 9.2.4.3 Iincwadi ezisemthethweni kanye nokutlolelana;
- 9.2.4.4 Eminye imisebenzi yokuzibandakanya kwababambisani; kanye
- 9.2.4.5 Nokulalelwa komphakathi namkha ukubonisana nenye ikambiso esemthethweni.

9.2.5 IFundiso yabaThengi

Ngaphandle komutjhwana 9.1.3 ongehla, i-FSCA izakuthatha amagadango afaneleko nazwakalako ukuqinisekisa bona iraga ifundiso yabathengi kanye nemihlangano ngelwazi lezeemali ngamalimi amanengi asemthethweni ngendlela ekukghoneka ngayo, ngokutjheja ilimi elikhethwa mphakathi okhambela imihlangano leyo. Phezu kwalokho, i-FSCA izakuba neensetjenziswa eziqathekileko zefundiso yezeemali yabathengi ezitjhugululelwe kiwo woke amalimi asemthethweni begodu zigadangiswe kuwebhusayidi yayo yomnqopho lowo <http://www.fscamymoney.co.za> ngokukhambisana negunya le-FSCA lefundiso yabathengi.

9.2.6 Isentha yemitato

Isentha yemitato ye-FSCA izakulwela ukwenza bona kube nokukhulumisana namalunga womphakathi ngawo woke amalimi asemthethweni weRiphabhliki njengombana kuvezwe emutjhwani 2.1 womGomo lo.

9.3 Ukunikelwa kwezenzelwa ngelinye ilimi kunangamalimi asemthethweni amukelwe yi-FSCA

9.3.1 Lapho ilunga lomphakathi lifisa ukuthola izenzelwa ngelimi elisemthethweni kunangamalimi asetjenzisiweko (isib. kumgadango), ilunga elinjalo kufanele lazise i-FSCA ngokutlola ngesibawo esinjalo, esinqotjhiswe kuSazi samaLimi esiPhezulu. I-FSCA izakwenza amalungiselelo wokuhlangabezana nesibawo esinjalo kungakapheli isikhathi esingaphasi kwamalanga ama-30 wokusebenza ngemva kokuthola isibawo.

9.3.2 Ebujamweni bokukhulumisana ngomlomo, njengemihlangano kanye nanyana ngimiphi eminye iminyanya lapho kutlhogeka khona ukutoliga, isibawo kufanele senziwe ngokutlola begodu okungenani ngamalanga wokusebenza ama-30 ngaphambi komnyanya loyo.

9.4 Ukunikelwa kweSenzelwa se-SASL ne-Braille

I-FSCA izakuthatha amagadango azwakalako begodu aqakathekileko ukufaka hlangana ukutjheja ukufumana, ukufaka hlangana ukutoliga nge-SASL, amafomethi alalelwako kanye namanye amafomethi afumanekako afana ne-Braille, ehlelweni layo lokuthintana, khulukhulu ukuzibandakanya komphakathi okukhulu kanye nokumumethweko namkha amahlelo wefundiso yabathengi ngokukhambisana nomutjhwana 9.1.3 ongehla.

10. UKUSUNGULWA KANYE NESAKHIWO SEPHIKO LOMSEBENZI WAMALIMI E-FSCA

10.1 Njengombana kufunwa sigaba 7 somThetho, i-FSCA yasungula iphiko lomsebenzi wamalimi ngo-2014, njenganje esele lifakwe emNyangweni

wezokuThintana. Umsebenzi wephiko leli kunikela ngokuphathwa kuhle kwamalimi ngaphakathi kwe-FSCA nokuqinisekisa ukufakwa nokuvikelwa kwabathengi bezenzelwa zezeemali ngezenzelwa ezisebenzako zamalimi.

- 10.2 Iphiko lomSebenzi wamaLimi le-FSCA lirholwa sisazi samalimi esiphezulu, sisekelwa mamanye amalunga wabasebenzi njengombana kungafunwa yi-FSCA ngezinye iinkhathi. Lineensetjenziswa ezaneleko ukusekela umsebenzi walo ngepumelelo nangokukhambisana nomthetho.
- 10.3 Iphiko lomsebenzi wamalimi lizakutjheja ukusetjenziswa komGomo lo ngeenkhati ezithileko, ukufaka hlangana ikambiso yeembawo zamalimi, iinghonyoyilo kanye neendingo zokufumana begodu nokunikela imibiko yangaphakathi ukusekela ukuthuthukiswa okuragela phambili.

11. UKUBANDULA NEKGHONO

Kobana kufikelelwe ukusetjenziswa okusezingeni eliphezulu nangepumelelo komGomo lo, umNyango wezokuThintana uzakuqinisekisa bona kunibandulo elaneleko nekggono lokwenza umsebenzi wawo.
